

**SEBRING STABLES**  
**STALLION BREEDING CONTRACT**

1. Mare Owner(s) hereby purchase a breeding service to the Morgan Stallion, \_\_\_\_\_, AMHA Number \_\_\_\_\_. Owner(s) are purchasing this service for the Morgan Mare \_\_\_\_\_, AMHA # \_\_\_\_\_.
2. Stallion is standing at stud at Sebring Stables for the \_\_\_\_\_ breeding season beginning February 15th and ending July 15th. No mare will be bred before or after those dates.
3. Mare Owner(s) hereby agree to pay a breeding fee of \$\_\_\_\_\_. Of this amount, a non-refundable booking fee of \$\_\_\_\_\_ should be returned with this signed contract. The balance of \$\_\_\_\_\_ is due before the first shipment of transported semen.
4. Mare Owner(s) further agree to pay a fee of \$\_\_\_\_\_ for each semen collection. Payment for the first semen collection is due prior to any shipment of semen. This fee covers the cost of delivering the semen via next day service from Fedex or other ground service. Any additional costs for shipping will be the expense of the Mare Owner(s).
5. Mare Owner(s) agree to provide a \$300 refundable deposit for shipping containers and to pay a penalty charge of \$15 per day for any container not returned to Sebring Stables within seven (7) days following the date semen is shipped to the Mare Owner(s).
6. All requests for semen shall be filled as received, subject to availability of semen.
7. Stallion Owner/Manager agrees to use best efforts to ship semen upon reasonable notice and assumes responsibility only to deliver semen to Federal Express or another ground carrier designated by Mare Owner(s). Stallion Owner/Manager is specifically not responsible for costs or issues associated with transportation and delivery delays and specifically makes no warranties or representations with respect to the semen except that it is the semen of the named stallion and that it was viable when it left Sebring Stables.
8. Mare Owner(s) agree that semen will be administered by a licensed veterinarian on the day of delivery or the Mare Owner(s) shall be considered to have breached the contractual obligations.
9. Frozen semen is available at an extra charge from Select Breeders Service, Inc. If the use of frozen semen is contemplated, please request further information.
10. Mare Owner(s) agree to provide documentation that mare is in sound breeding condition and free of infection as determined by a certified veterinarian/lab. Mare Owner(s) assume all responsibility for the condition mare and the risk of loss to mare whether by death, disease, injury, infection or otherwise, and by any cause whatsoever, and therefore agree to hold the Stallion Owner/Manager (or any person employed by or associated with the Stallion Owner and/or Manager) harmless for any and all damages associated therewith.

11. All breeding fees are non-refundable. Should mare fail to get in foal or fail to produce a live foal (defined as one that stands and nurses), Mare Owner(s) will be entitled to a return breeding season under the terms of the then current breeding contract and upon payment of the then current booking fee. In order obtain these rebreeding rights, Mare Owner(s) must notify Sebring Stables in writing of the mare's failure to get in foal within 30 days after the end of the breeding season or of the abortion, reabsorption or failure to have a live foal within 5 days of such event.  
In any event, all breeding rights under this contract shall expire two (2) years after the date of first service to the mare named in this contract.
12. Sebring Stables reserves the absolute right to refuse acceptance of any mare under this Contract.
13. Service certificates/registration papers will not be signed/supplied unless all charges are paid in full.
14. This Contract constitutes the entire agreement between the parties and may not be amended or modified, except by a mutual exchange of written instruments. Nor may this Contract or any rights or obligation hereunder be assigned without the proper written consent of both parties. Any dispute arising under this contract or regarding any aspect of this breeding to the mare will be resolved in the courts of and according to the laws of the State of Massachusetts.
